**Welcome**

A presentation format was used throughout the meeting. The Chair opened the meeting and welcomed everyone to Copeland Amateur Swimming Club's Annual General Meeting. Full presentation attached.

**2024 AGM Minutes agreed.**

Chair gave a presentation and provided detail on the club's achievements throughout 2025, also gave overview of the work carried out by volunteers to ensure the club continues to run in accordance with swimming guidelines. The Chair thanked all volunteers for all their efforts – committee, coaches, officials, timing helpers and front of house.

The Chair also spoke about the Governance in the club and achieving the Swimmark and updating the club constitution.

In 2024/25 there was a lot of change of roles – Secretary /Treasurer/ Membership secretary / Welfare officer.

Copeland is represented well within the Cumbria ASC with Ian Richardson as President, John Connery as Chairman and Keith Chisholm as Treasurer and John Freestone as past President. A lot of experience who are happy to advise.

John Connery highlighted the importance of SwimMark and the need to be compliant, Claire completing level 2 coaching, without the work of committee would not be a competitive swimming club.

## **Treasurer Report**

Treasurer gave a presentation and provided detail on the club's financial position, including the overall income and expenditure for 2025, 2025/2026 budget, the importance of fundraising and detail on the club's main income streams

Treasurer's recommendations for 2025/2026

- Adopt the accounts as an accurate record
- Continue as a charity
- Hold membership fees until the new calendar year and review position considering squad balance and increase in Swim England membership fees.
- Continue fundraising options.

Independent review of account will be carried out by Toni Graham.

Questions and comments put to the Treasurer.

Q - MP- Do we always run at a minus?

A - AS- We tend to because hard to predict what fundraising will take place.

Q - NG – Are the membership fee in comparison to other clubs?

A - JC – very good compared to other clubs – South of county £100 a month per swimmer. To keep at £46 a month is very reasonable. Aim for membership fees to covers pool hire.

Q - TM – Fees not covered by a governing body? Shocked how cheap it is for time in the pool.

A – JC- No not governed

A – AS- Fees to be reviewed next year – do not want to increase the fees.

Treasurer proposed recommendations, seconded by Andy Sutton.

## **Coaches Report**

Head coach gave a presentation and provided an update on the pool success over the past 12 month. Claire thanked Richard for his hard work and commitment. The club stayed in division one in the arena league, a number of swimmers qualifying for Regionals and Nationals, swimmers achievements with club records broken and the introduction of a development squad targeted for Diddy league swimmer.

The coach also provided projections for 2025/2026 and thanked everyone for all their support over the past 12 month.

Claire also stressed the need for volunteers in assistant coaching and poolside helpers and the consequences without additional volunteers.

Q - Is there a plan to encourage off the balcony?

A – Keep asking – 1 volunteer going through training. It is not through lack of trying, really struggling with coaches.

JC Big effort from level 2 coaches because without their effort it stops.

Q – Winter meet target ages changed so has younger swimmers been taken into account?  
A – I did think about that but with changes in club decided to keep the target swimmers as 3.



# Copeland Amateur Swimming Club – Treasurers Report



- Current Account £11,115.03 decrease
- Reserve Account £136.81 increase (interest rates)
- Total decrease £7,586.20
- True year end position is £3,187.80 increase (See Caveat to Reporting).
- £25,323.28 in the bank with £3,392 cash held
- Club continues to be in a stable financial position.
- Membership numbers continue to grow
- Fee increases will not be proposed now but position will be reviewed in January 2026 due to ASA membership price increases.

# Copeland Amateur Swimming Club – Treasurers Report – Caveat to reporting



- Reported Loss for FY 2024/25 is £7,586.20
- As part of fundraising activities in the previous year Copeland ASC successfully secured a grant of £14,365 to improve our aging infrastructure.
- The 1<sup>st</sup> £10,774 had been paid into our accounts in 23/24 and used for it's purpose in 24/25.
- Taking this into consideration the true year end position is £3,187.80 increase.
- This is a good outcome and is largely down to hard work by a small number of dedicated people.



### **2025/26 Season – Club development**

- Overall, a really positive year on and off poolside.
- We lost a number of swimmers to other clubs but have seen a big increase in new swimmers joining across Learn to Swim and Squads.
- Morning session attendance is improving, with many younger and newer squad swimmers keen to develop and training more regularly.
- Introduced a new Development Session:
  - Targeted technique-focused sessions for Diddy swimmers and those needing extra support.
  - Already making a difference to skills and confidence in competition.
- Launched individual development plan opportunities for Upper B squad and above:
  - Swimmers can work with coaches to set and track specific goals.
- Arena League 2025:
  - We have completed two rounds so far, facing very tough competition.
  - Every swimmer has stepped up and represented the club brilliantly – as Head Coach, I'm proud of every performance.

#### **Competition & performance plans**

- As well as the usual short-course galas, we are also targeting four key long-course meets in 2025/26:
- Leeds New Year Meet – 50m experience for multiple squads.
- York National Qualifier – key opportunity for National times.
- Sunderland National Qualifier – performance focus for higher squads.
- Sunderland Summer Splash – broad 50m race experience across squads.
- We have already started developing the next two years' Diddy teams:
- Aim to improve our placing every year and get younger swimmers excited about galas.
- Maintain our philosophy that everyone of the right age should have the chance to be part of the team, even if it's just one swim, rather than selecting only the fastest.
- New season performance objectives (adjusted for recent leavers in higher squads):
- 4 swimmers to qualify for Summer Regionals.
- 3 swimmers to qualify for Winter Regionals.
- Maximise County Age Group entries – get as many as possible qualified and racing.
